Container Solutions – a new member in the Trifork Group

In the start of December, 2014 Trifork joined together with Jamie Dobson and founded the new company Container Solutions B.V.

Container Solutions is an IT company located in Amsterdam with the mission to provide professional services around Docker containers and other technologies in the infrastructure area.

Docker is an open platform for developers and sysadmins to build, ship, and run distributed applications.

Docker containers allow us to create multiple isolated and secure environments within a single instance of an operating system. As opposed to virtual machines (VMs), containers do not launch a separate OS but instead share the host kernel while maintaining the isolation of resources and processes where required.

This architectural difference leads to the drastic reduction in the overheads related to starting and running instances. As a result, the startup time can commonly be reduced from thirty plus seconds to 0.1 seconds. The number of containers running on a typical server can easily reach dozens or even hundreds while the same server would struggle to support ten to fifteen VMs.

Container Solutions offers [standard services](#), helping clients to implement Docker, and [premium services](#), helping customers to analyse their current state and help further with technical strategy and management consultancy.

“We are of the belief that a platform like Docker will be something that a lot of your customers can benefit from and therefore it’s very important for us to be experts on this”, says Jørn Larsen, CEO of Trifork, and continues: “Our ambition is to be in front on this technology and grow Container Solutions in an international context together with the rest of the Trifork group”.

“We look forward to develop our company together with Trifork and are very eager to be part of the international growth of the Trifork Group”, says Jamie Dobson, CEO and co-founder of Container Solutions.

Trifork owns just over 50% of Container Solutions and the financial results from the company will be consolidated in the Trifork Group. The content of this announcement will however not have any influence on the previously announced expectations for Trifork in 2014. Trifork expects in 2014 total revenue of EURm 41.5 and an EBITDA of EURm 5.1
